Please summarize Record of contributions with regards to publications, monographs, books authorized, projects and patents, flying hours, maintenance and other related aviation and aerospace activities. 4. The process of election requires scrutiny and recommendation of the Grading Committee and approval by the Governing Council. Generally, the applications will be reviewed once in a year in April and November.
